Scope

Studies in the Philosophy of Sociality publishes research devoted to the basic structures of the social world. It focuses on phenomena ranging from small scale everyday interactions to encompassing social institutions. The unifying element is its focus on the basic constitution of these phenomena, and its aim is to provide philosophical understanding of the foundations of sociality.

The book series covers the part of philosophy of, and for, the social sciences which deals with questions of social ontology, collective intentionality (e.g. collective knowledge, joint and collective action, joint mental states) and related philosophical topics. The series will include monographs and edited collections on philosophical and conceptual questions concerning social existence as well as conceptual and theoretical analyses of social notions and collective epistemology. In principle, all phenomena dealing with sociality are covered as long as they are approached from a philosophical point of view, broadly understood. Accordingly, the works to be published in the series will in general be philosophical—without regard to philosophical schools and viewpoints—and they will meet the highest academic and intellectual standards.

The series accepts high-level submissions not only from various subfields of philosophy but also from other, neighboring disciplines, including political science, economics, sociology, psychology, linguistics, neuroscience, evolutionary biology, and artificial intelligence. The resulting interdisciplinary approach will give new perspectives to the study of topics such as social interaction, communication, unintended consequences of action, social structures and institutions, the evolution of collective intentionality phenomena, as well as the general ontological architecture of the social world.

Readership

The main target audience consists of philosophers, especially those working in the fields of philosophy of the social sciences or in social and political philosophy. In addition, the audience will include researchers from adjoining disciplines actively involved with conceptual studies of the social world, such as economists, sociologists, psychologists, linguists, neuroscientists, evolutionary biologists, and researchers in artificial intelligence.
